Old Business:

Debra is going to follow up with Chris on getting our fundraising check from Togo's for our October fundraiser.

Megan was working on changing the booster club's official name from GK Girls Booster Club to Oceanside Gymnastics Booster Club. Dan will follow up with her on the status of this.

New Business:

We discussed the benefits of paying coach's fees instead of meet fees going forward. Ideally, we would like to pay both, but have to choose one for a primary. It was decided that we would send out a ballot via email in order to get everyone's vote included. A cap amount was set for both compulsory and optional gymnasts; \$75 for compulsory and \$120 for optional.

We would like to get ideas from members on more ways to make an impact on our community. Corporate sponsors like to see that an organization they donate to gives back to the community.
